- 1. The 2023-2024 property tax request be set at General Fund \$9,750,000.00 and Bond Fund \$1,182,317.50.
- 2. The total assessed value of property differs from last year's total assessed value by 6 percent.
- 3. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property would be 0.317678 per \$100 of assessed value.
- 4. Holt County proposes to adopt a property tax request that will cause its tax rate to be 0.354890 per \$100 of assessed value.
- 5. Based on the proposed property tax request and changes in other revenue, the total operating budget of Holt County will increase last year's budget by 8 percent.
